### **ROLE SUMMARY**

In the face of unprecedented domestic and international challenges, there is a vital need to deliver an exponentially more ambitious and creative malaria change plan in the UK and across the world in order to meet the threats and opportunities which under-prioritisation, stalling funding, and the huge challenge the Covid-19 pandemic pose to the global malaria fight.

2022 is a critical year for global anti-malaria funding and action. The Global Fund to Fight Aids, TB and Malaria – the biggest single funder and deliverer of anti-malaria programming in the world - will seek its seventh replenishment. In the UK and other key donor countries, the challenge to secure the extra funding needed to overcome the impact of the pandemic will be considerable. It is hoped that the global malaria and NTDs summit, due originally to have taken place in June 2020, will be rescheduled for June 2022 on the sidelines of the expected Commonwealth Heads of Government Meeting in Rwanda, representing another significant opportunity to advance the malaria cause with world leaders. Malaria No More UK will play a key role both globally and in the UK, working with its partners to deliver impactful campaign communications and targeted, politically on point advocacy activities that deliver the right pressure at the right time to secure the big decisions the malaria fight needs.

Malaria No More UK is looking for an experienced and talented senior adviser with strong experience in developing coherent, evidence-based policy positions and advocacy arguments that play into key identified political opportunities, particularly in the UK/global health context. The role is a crucial member of an integrated team of sector-leading advocates, media and communications experts which have played a key role in building and defending the UK's global leadership on malaria in the last decade. The new occupant of the role will join at an exciting time as opportunities emerge to cement the malaria fight in a new global push for greater health security, and to build on the new momentum for scientific innovation – including in malaria vaccines - in prevention and treatment. The role reports directly to the Director of Advocacy and manages a policy officer in support of this vital work.

## **KEY RESPONSIBILITIES**

- Supporting the UK campaign in developing key policy and campaign propositions and arguments for the UK government, working hand in glove with advocacy and communications colleagues
- Playing a key role in developing the content needed to deliver supportive news coverage, working closely with the media team
- Acting as principal liaison with the FCDO's malaria policy team
- Maintaining and strengthening relationships with key external partners and institutions (global health organisations including WHO, the Global Fund and GAVI, research and development institutions, and key pharmaceutical and other private sector partners)
- Supporting the work of the global malaria campaign, particularly through working with international partners to develop the key arguments and positions for international summits (e.g. the Kigali NTDs and malaria summit expected in June 2022), replenishments (Global Fund and GAVI), and intergovernmental partnerships.
- Where needed supporting MNMUK's new capacity-building workstream in African endemic countries
- Positioning Malaria No More UK/malaria in key global health trends/debates/platforms
- Supporting other teams as needed to develop full spectrum partnerships with key private, public/private and public sector bodies
- Oversight of cross-organizational support on policy messaging and use of accurate, up-to-date terminology and statistics.
- Line Management of the Policy Officer post
- Some travel may be required to Africa and/ or Europe, sometimes at short notice

- Strong copywriting skills able to translate complex content into language the public and media can be motivated by
